3 - Problem Statement

The digital asset space is flooded with **memecoins, NFTs and collectibles**, yet few projects successfully merge these elements into something both fun and meaningful. Many memecoins exist purely for speculation, offering little to no real-world utility, while books and traditional storytelling often lack integration with modern digital trends. This creates a unique opportunity to blend these worlds in an engaging and rewarding way.

BUDYZ aims to bridge this gap by combining **memecoins, NFTs and storytelling** into an innovative ecosystem. Inspired by a beloved pug, **BUDYZ** goes beyond being just another meme—it introduces a digital **book featuring Bud's adventures, interactive NFT collectibles** tied to challenges and community-driven **rewards for \$BUDYZ holders.**

By integrating entertainment with practical utility, **BUDYZ** offers a fresh, engaging experience that keeps users invested while celebrating the charm of **Bud.** 🚀🐾

4 - BUDYZ Solution

BUDYZ is launching on **Solana** as an **SPL Token**, leveraging the network's ultra-low fees, high throughput, and lightning-fast transactions to ensure scalability and accessibility for all users.

The **\$BUDYZ token** was minted through **20Labs**, a trusted **Solana minting platform**, with a fixed total supply of **5,000,000,000 tokens.**

The **mint authority** has been permanently **revoked**, guaranteeing that no additional tokens can ever be created. This ensures that the token supply is capped forever, reinforcing our long-term commitment to transparency, trust, and decentralization.

All **tokenomics allocations** are clearly defined and fully auditable on-chain, providing the community with verifiable proof of integrity and fairness. 🚀🐾

5 - Tokenomics

The tokenomics of BUDYZ (\$BUDYZ) are designed to foster a thriving ecosystem, reward the community, and ensure long-term sustainability. With a total supply of **5,000,000,000 \$BUDYZ**, distribution has been carefully structured to incentivize all stakeholders while keeping the project community-driven.

Token Allocation:

- **5% Community Rewards (250,000,000 \$BUDYZ)**
 - A dedicated portion of the supply is reserved for **airdrops, giveaways, and promotional campaigns to kickstart community engagement and raise awareness.**
- **5% Strategic Partnerships (250,000,000 \$BUDYZ)**
 - This allocation is reserved for **partnerships** that strengthen and expand the **Budyz ecosystem**. These tokens may be used to support collaborations, integrations, joint initiatives, and other strategic relationships that contribute to long-term growth and purpose-driven development.
- **5% Deflationary Program (250,000,000 \$BUDYZ)**
 - To strengthen long-term value and trust, **5% of the total supply (250 million \$BUDYZ)** is allocated to the **Deflationary Program**.
- **5% Budyz Foundation (250,000,000 \$BUDYZ)**
 - Allocated to **The Budyz Foundation** to support animal-welfare, rescue actions, and ecological initiatives. This allocation will be used as part of the liquidity-based funding model, **pairing with USDC in liquidity pools** to generate USDC rewards **to promote eco-friendly initiatives.**
- **5% Budyz.XYZ Startup (250,000,000 \$BUDYZ)**
 - Dedicated to the **Budyz.XYZ Startup**, responsible for future carbon-credit integrations and eco-market development. These tokens will be **paired with USDC in liquidity pools**, enabling the startup to accumulate USDC rewards used **to purchase carbon credits.**
- **10% Reserve Fund (500,000,000 \$BUDYZ)**
 - Set aside for future initiatives such as **marketing strategies, unforeseen expenses, and ecosystem expansion**. This reserve provides flexibility for scaling, integrating with other platforms, and supporting new developments as **BUDYZ** evolves.
 - For future collaborations and integrations — a **Strategic Ecosystem & Partnerships Reserve**.
- **15% Author & Team (750,000,000 \$BUDYZ)**
 - Reserved for the **'development team'** behind **BUDYZ**, ensuring long-term commitment to the project's success while aligning team incentives with sustainable growth.
- **50% Liquidity Pool (2,500,000,000 \$BUDYZ)**
 - Allocated to establish and sustain liquidity within the **Solana** ecosystem. This portion ensures that **\$BUDYZ** remains easily tradable and accessible. A strong liquidity pool reduces volatility, attracts market participants, and supports long-term price stability and trust in the token. 🚀🐾

6 - Liquidity & Market Stability

- **Token Model**

BUDYZ (\$BUDYZ) is deployed as a **fixed-supply SPL token** on the **Solana blockchain**, ensuring long-term scarcity, transparency, and predictability. The entire supply of **5,000,000,000 tokens** was minted at launch, and the **mint authority** has been **permanently revoked**. No additional tokens can ever be created, reinforcing our commitment to fairness, sustainability, and decentralized governance.

- **Liquidity Pool Allocation**

A total of 2,500,000,000 \$BUDYZ (50% of the total supply) will be allocated to the liquidity pool, ensuring sufficient market depth and smooth trading.

- **Trading & Pairing**

BUDYZ will be deployed on the **Solana Blockchain** and it will initially trade on decentralized exchanges (DEXs) such as **Raydium**.

- **Custom Token:** \$BUDYZ
- **Pairing Token:** USDC (USD COIN) for price stability and liquidity.
- **Initial Price:** 0.00001 USDC per \$BUDYZ

- **DEX Micro-Listing**

A small initial pool of **4,000,000 \$BUDYZ at 0.00001 USDC** was added to **Raydium** in September, 2025. This milestone marked **Budyz's first market entry**, improving token visibility and helping the community learn how to create **Associated Token Accounts (ATAs)** for future airdrops.

- **Liquidity Locking for Investor Confidence**

To enhance trust and market stability, **50% of the total \$BUDYZ supply** will be dedicated to liquidity and locked for one year using reputable **Solana-native platforms** such as **Solock or Lockup.sol**.

This firm commitment ensures long-term security, deters rugpull concerns, and establishes **BUDYZ** as a transparent, investor-focused project.

- **Liquidity Growth Strategies**

To ensure healthy trading activity, deep market liquidity, and long-term price stability, the **BUDYZ** project will adopt the following flexible, manual strategies:

- **Strategic Treasury Injections**
 - The team may allocate portions of the reserve fund to reinforce liquidity, reduce volatility, and maintain optimal trading conditions as the market evolves.

- **Community Liquidity Boosts**

Future campaigns, partnerships, or incentive programs may include opportunities for community-driven liquidity contributions. 🚀🐾

6.1 - Liquidity-Based Eco-Funding Model

- **Overview**

The **BUDYZ ecosystem** integrates a **liquidity-powered sustainability engine** designed to fund both **The Budyz Foundation** and **The Budyz.XYZ Carbon Startup** without selling **\$BUDYZ**. By pairing their allocations with **USDC** in the **BUDYZ/USDC liquidity pool**, both entities generate continuous **USDC rewards** through natural market activity. This model protects token value, reinforces trust, and ensures long-term ecological and animal-welfare impact.

- **Liquidity-Based Funding Mechanism**

When the **Foundation Wallet** and **Budyz.XYZ Carbon Credit Wallet** provide liquidity, **Raydium's AMM** model distributes rewards in the same assets held in the pool:

- **USDC**
- **\$BUDYZ**

These rewards accumulate automatically from trading volume. **USDC** becomes the operational currency for ecological and carbon-credit actions, while **\$BUDYZ** rewards remain within the ecosystem.

- **BUDYZ Foundation Model**

The **Foundation's 250 million \$BUDYZ** allocation strengthens liquidity and yields recurring **USDC**. This **USDC** funds animal-care missions, ecological protection efforts, and operational initiatives— all without selling tokens.

- **The BUDYZ.XYZ Carbon Startup Model**

The **Carbon Credit Wallet's 250 million \$BUDYZ** allocation follows the same mechanism. Its **USDC** rewards are used to purchase carbon credits, enabling regenerative impact and future integration with tokenized carbon markets—all without token liquidation.

- **Zero Selling Pressure**

- The liquidity-engine model ensures:
 - No selling of **\$BUDYZ by Foundation or Budyz.XYZ**
 - **USDC** exclusively funds missions and carbon-offset actions
 - **\$BUDYZ** rewards are recycled into treasury or liquidity

This approach preserves price stability and strengthens long-term ecosystem credibility.

7 - DEX Liquidity Expansion Plan

- **Stage 1 – Liquidity Expansion**

- **Date:** December 2025
- **Liquidity Pool Size:** 100,000,000 \$BUDYZ + \$1,000 USDC
- **Purpose:**
 - Strengthen **Budyz's** market depth and price stability.
 - Support smooth trading conditions for the growing community.
 - Expand liquidity in preparation for future campaigns and listings.
 - Limit speculative rush.

- **Stage 2 – First Liquidity Boost**

- **Date:** Q2 2026 (around April)
- **Add:** 150,000,000 \$BUDYZ + proportional USDC to maintain price stability.
- **Total LP:** 250,000,000 \$BUDYZ
- **Goal:**
 - Support a larger trading base.
 - Still keep liquidity modest to avoid whale manipulation.

- **Stage 3 – Community Growth Liquidity**

- **Date:** Q3 2026 (around September)
- **Add:** 500,000,000 \$BUDYZ
- **Total LP:** 750,000,000 \$BUDYZ
- **Purpose:**
 - Match higher transaction volumes.
 - Tie liquidity expansion to major community events.

- **Stage 4 – Midpoint Liquidity Expansion**

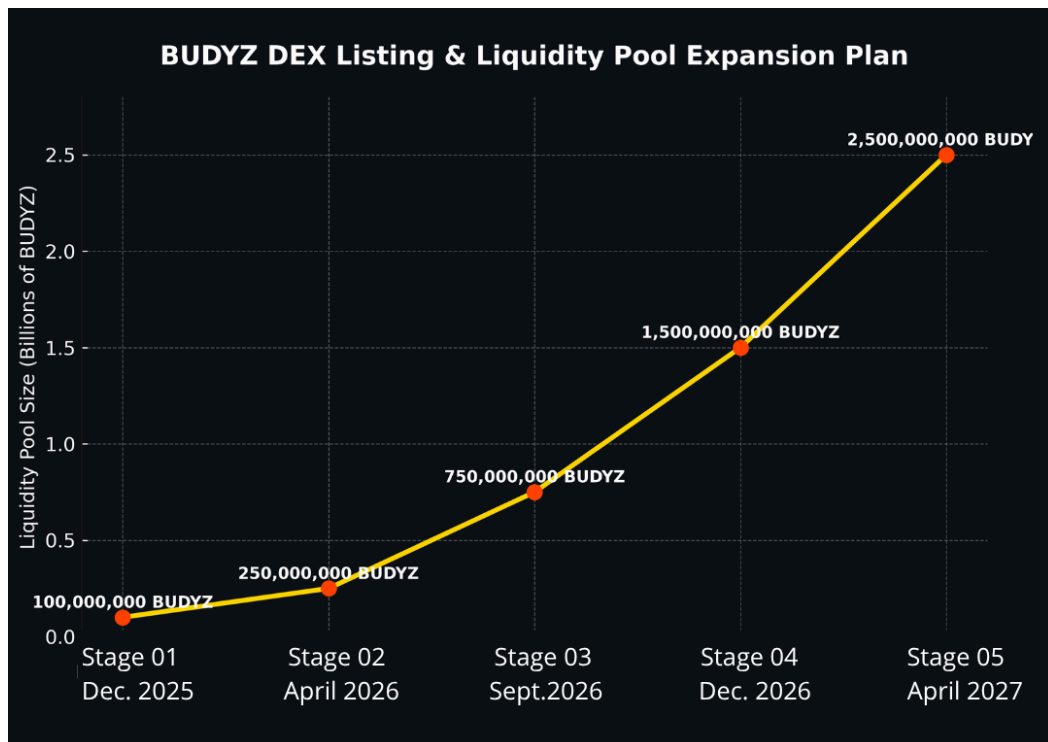
- **Date:** Q4 2026 (around December)
- **Add:** 750,000,000 \$BUDYZ
- **Total LP:** 1,500,000,000 \$BUDYZ
- **Purpose:**
 - Increase trading stability.
 - Allow for broader token adoption on multiple DEXs.

- **Stage 5 – Full Target Liquidity Pool**

- **Date:** Q2 2027 (around April)
- **Add:** 1,000,000,000 \$BUDYZ
- **Final LP:** 2,500,000,000 \$BUDYZ
- **Purpose:**
 - Support mainstream trading without heavy volatility.
 - Facilitate CEX listings and deeper liquidity pools.

- **Core Safeguards:**

- **Controlled Release** – All expansions will be announced weeks in advance to avoid sudden speculation.
- **Reserve Management** – Unlisted LP tokens will be stored in a multi-sig wallet for transparency.
- **Anti-Dump Awareness** – Community Education about long-term holding incentives will be promoted along the listing periods. 🚀🐾



Raydium Listing Strategy

As part of our phased approach to market integration, the **BUDYZ team** has chosen to initiate trading through a limited listing on **Raydium**, one of Solana's leading decentralized exchanges.

• Main Liquidity Pool Lock – Formal Disclaimer

Upon completion of the **Liquidity Expansion Plan**, the project commits to **permanently locking** the main liquidity pool. All corresponding LP tokens will be transferred to an irretrievable address, making any future withdrawal, reduction, or alteration of the core liquidity mathematically impossible. By implementing this measure, the project formally renounces any operational ability to influence, extract, or manipulate the liquidity associated with the primary trading pair. This guarantee serves as **a long-term protective mechanism** for the community and ensures that the market structure remains fully transparent, immutable, and insulated from any actions that could compromise investor trust.

BUDYZ will grow at its own pace, with its own values. 🐾🚀

- **Anti-Dump Protections**

BUDYZ liquidity is established directly within the **Solana** ecosystem, ensuring transparent and verifiable on-chain market access. By combining a locked liquidity pool, phased exchange listings, and clear tokenomics, **\$BUDYZ** protects against short-term volatility and reinforces long-term holder confidence with a **fixed supply permanently capped at 5B tokens**.

- **Burn Mechanism**

To strengthen long-term value and scarcity, a **Deflationary Program** will be applied through periodic burn events tied to key community milestones. These supply reductions reinforce sustainability and reward committed holders.

- **Deflationary Program**

To reinforce scarcity and reward long-term supporters, **5% of the total supply (250 million \$BUDYZ)** has been pre-allocated to the **Deflationary Program**. Tokens from this pool will be burnt in increments of **50 million \$BUDYZ** upon reaching major community milestones of **5,000; 10,000; 15,000; 20,000 and 30,000 holders**.

This milestone-based approach ensures that supply reductions are directly tied to community growth, creating lasting value for holders while celebrating collective progress.

- **Exchange Listing**

A CEX listing will be pursued once the **DEX Listing & Liquidity Expansion Plan** is complete and market conditions align for a strong, sustainable debut.

- **Governance & Transparency**

All significant changes—**such as adjustments to liquidity, supply, burns, or partnerships**—will be subject to transparent governance proposals. As the holder base matures, structured voting mechanisms will be introduced to expand community decision-making power.

- **Long-Term Impact**

The cumulative effect of burning **5% of the total token supply** is designed to increase the value of the remaining tokens by making them more scarce. As fewer tokens circulate, holders may begin to perceive the token as a more valuable asset, encouraging longer-term holding behavior. Additionally, these burn events demonstrate a commitment to deflationary economics, which can help foster trust within the community and attract new investors.

It's important to note that while the burns are designed to create deflationary pressure, the project will continue to prioritize the health of the ecosystem.

- **Future Token Burns**

Future strategic decisions, including **potential additional burns**, will be openly discussed within the community to maintain a balanced approach between liquidity and token utility. 🚀🐾

8 - Liquidity Lock Plan

- **Overview**

Liquidity is the backbone of the **BUDYZ ecosystem**. It provides stability, reduces slippage, safeguards market structure, and ensures that all community members can buy or sell the token in a transparent and predictable environment.

To guarantee **long-term trust** and prevent any form of liquidity manipulation, BUDYZ adopts a clear, verifiable, and irreversible liquidity-lock strategy aligned with best practices in the Solana DeFi landscape.

8.1 - Main Liquidity Pool: Permanent Lock Commitment

The central principle of our liquidity design is simple:

The main liquidity pool will be permanently locked once the Liquidity Expansion Plan is fully completed.

Upon reaching the final expansion wave, all **LP (Liquidity Provider)** tokens associated with the main **BUDYZ-USDC pool** will be transferred to an irrecoverable burn address.

This action makes the liquidity mathematically impossible to withdraw, alter, or repurpose.

- **Formal Guarantee**

- No individual, team member, or external entity will possess the ability to remove or modify the primary liquidity.
- This measure eliminates any risk of a rug pull.
- It provides lifelong protection for the community and ensures a stable trading environment.

The permanent lock becomes a public good of the **BUDYZ ecosystem**.

- **Liquidity Expansion Plan Framework**

The **BUDYZ** liquidity strategy relies on a multi-wave approach designed to gradually grow market depth while avoiding price shocks.

- **Core Liquidity Allocation**

- 50% of the total supply (2.5 billion \$BUDYZ) is dedicated exclusively to liquidity.
- This liquidity is deployed in structured phases, aligned with project milestones and market growth.

- **Expansion Waves**

- Adding a new batch of BUDYZ + USDC
- Receiving LP tokens
- Holding LP tokens until the expansion plan is fully complete

Only after the final wave:

→ All LP tokens will be burned permanently. 🚀🐾

8.2 - Secondary Liquidity Sources (Foundation & BudyzXYZ)

Two additional wallets (Foundation Wallet and BudyzXYZ Wallet) may contribute liquidity in later phases.

However, unlike the main pool, these contributions will not be locked until a future decision is made.

- **Foundation Wallet (250M BUDYZ)**

- Purpose:
 - Future funding for The BUDYZ Foundation
 - Supporting animal welfare, ecological actions, and long-term social programs
- Liquidity Role:
 - May add liquidity during future phases
 - Liquidity lock will be evaluated once the Foundation's operational framework matures

- **BudyzXYZ Wallet (250M BUDYZ)**

- Purpose:
 - Funding the carbon-credit engine
 - Powering the Budyz Eco-Market
 - Supporting long-term sustainability initiatives
- Liquidity Role:
 - Will add liquidity during the expansion plan
 - Final locking method will be decided in the future based on product development needs

- **This approach balances:**

- Trust
- Transparency
- Operational flexibility

8.3 - Author Wallet

- The author allocation (15% of total supply) remains independent from liquidity operations.
- This allocation:
 - Ensures long-term leadership incentive
 - Supports future strategic initiatives
 - Remains untouched for the moment
 - Does not participate in liquidity locking
- This structure reassures the community while maintaining founder skin-in-the-game. 🚀🐾

8.4 - Liquidity-Lock Mechanism Options

During the final stage of the Liquidity Expansion Plan, one of the following mechanisms will be executed to guarantee the permanent lock:

- LP tokens are sent to an unrecoverable address (For Main Liquidity Source):
 - Impossible to reverse
 - Impossible to withdraw
 - Fully transparent on-chain
 - This method is the strongest form of liquidity lock on Solana.
- Multisig Lock (For Secondary Liquidity Source):
 - Squads multisig
 - Goki multisig
 - Realms-based governance
 - This ensures collective control without compromising future updates.
- Time-Lock Contract (Optional)
 - LP tokens may be time-locked in a contract for a defined period.
 - Used only if a structured vesting or governance vote is required.

- Final Decision:

→ The main pool will be LP-burn locked.

→ Secondary liquidity will follow a governance decision later.

8.5 - Community Impact and Market Integrity

- By permanently locking the main liquidity, BUDYZ ensures:
 - Irreversible protection against rug pulls
 - Full transparency
 - Stable long-term pricing
 - Institutional-grade market confidence
 - Stronger path toward centralized exchange listings
- A trustworthy foundation for all ecosystem pillars (Foundation, Studio, BudyzXYZ)
- This mechanism demonstrates the project's commitment to ethical practice and long-lasting value creation.

8.6 - Formal Statement for Investors

- The BUDYZ project hereby declares that upon completion of the Liquidity Expansion Plan, all LP tokens associated with the main liquidity pool will be permanently and irreversibly locked by transferring them to an unrecoverable address.
- No entity—internal or external—will retain the capability to withdraw or modify the core liquidity. 🚀🐾

9 - Solana Blockchain

BUDYZ has chosen to launch its token on **Solana**, a high-performance blockchain known for lightning-fast transactions and minimal fees.

By leveraging platforms like **Raydium**, we ensure a fair, transparent, and cost-effective launch — with built-in liquidity locks and seamless trading tools.

This move allows **BUDYZ** to scale faster and meet community expectations while keeping our **NFT campaigns active on Polygon** and reward programs integrated with the **Pi Network**.

This multichain strategy ensures that **BUDYZ** is positioned for broad adoption, continuous engagement, and community-first scalability across ecosystems.

One token. Multiple chains. Unlimited community potential.

10 - Website Creation: Wix.com

To establish an accessible and user-friendly digital presence for **BUDYZ**, we have chosen **Wix.com** for the creation of our official website. **Wix's** drag-and-drop tools provide an efficient and cost-effective way to set up an engaging online platform with minimal technical expertise.

- **Ease of Use:** **Wix** allows us to rapidly deploy a visually appealing and responsive website for **BUDYZ**.
- **Customization:** The platform's flexibility supports custom integrations which will allow us to make digital books and NFTs available; live token price feeds and the latest news related to **BUDYZ**.
- **Scalability:** As the community and ecosystem grow, **Wix's** robust set of features allows us to easily expand the site, add e-commerce capabilities and integrate additional functionalities.

11 - Marketplace Integration: OpenSea.io for NFT Creation and Distribution

BUDYZ leverages **OpenSea.io** — the world's largest decentralized NFT marketplace — to host and distribute its core **NFT collections**. These include **The BUDYZ 500**, **The Budyz Genesis Badge**, and **The Budyz PI Edition Badge**, all of which are available on the **Polygon Network**.

By utilizing **Polygon's low-cost infrastructure**, we ensure NFT accessibility while avoiding high gas fees. The **OpenSea** integration provides a user-friendly platform for our community to collect, trade, and showcase their NFTs without needing direct interaction with the token contract.

While the **\$BUDYZ token** will launch on **Solana**, our **NFT ecosystem** remains fully operational and active on **Polygon** — creating a cross-chain experience where NFTs and token rewards coexist through community participation and verification. 🚀🐾

12 - E-commerce and Book Purchases: Amazon.com

We are exploring the possibility of using **Amazon.com** as a marketplace for the distribution of books, where buyers can purchase books and, in turn, contribute to **The Budyz Foundation**.

The majority of book revenues are reinvested into the Budyz ecosystem and its mission, ensuring long-term impact and continuity.

- **Book Distribution:** As part of the **BUDYZ** ecosystem development, the book "**Bud, A Lovely Pug's Life**" will be available for purchase.
- Revenue generated from book sales:
 - **70%** will be directed to **The Budyz Foundation**, supporting its mission to promote animal welfare and meaningful real-world impact.
 - **30%** will be allocate to creator sustainability & reinvestment.

13 - Trademark and Intellectual Property Protection: Trademark Engine

The intellectual property associated with **BUDYZ**, including its name, logo and associated branding, will be registered through **Trademark Engine**.

- **Trademark Registration:** **Trademark Engine** offers a simple and efficient process for registering trademarks, providing legal protection for **BUDYZ's** brand identity.
- **Legal Support:** The service ensures that **BUDYZ** is protected from infringement, reinforcing the project's professionalism and trustworthiness.

14 - Security and Transparency: Zeppelin Solutions

Security is a core pillar of the **BUDYZ** project, especially in the rapidly evolving landscape of decentralized finance. From the early development stages, we are committed to maintaining strong security practices and transparent processes.

- **CEX-Grade Final Audits:** A comprehensive audit will be conducted by **Zeppelin Solutions** prior to any centralized exchange listing (**CEX**). This ensures institutional-grade security, transparency, and readiness for broader market adoption. No additional audits are required prior to token launch, as **\$BUDYZ** will utilize trusted deployment tools on **Solana** through **20Labs platform**.

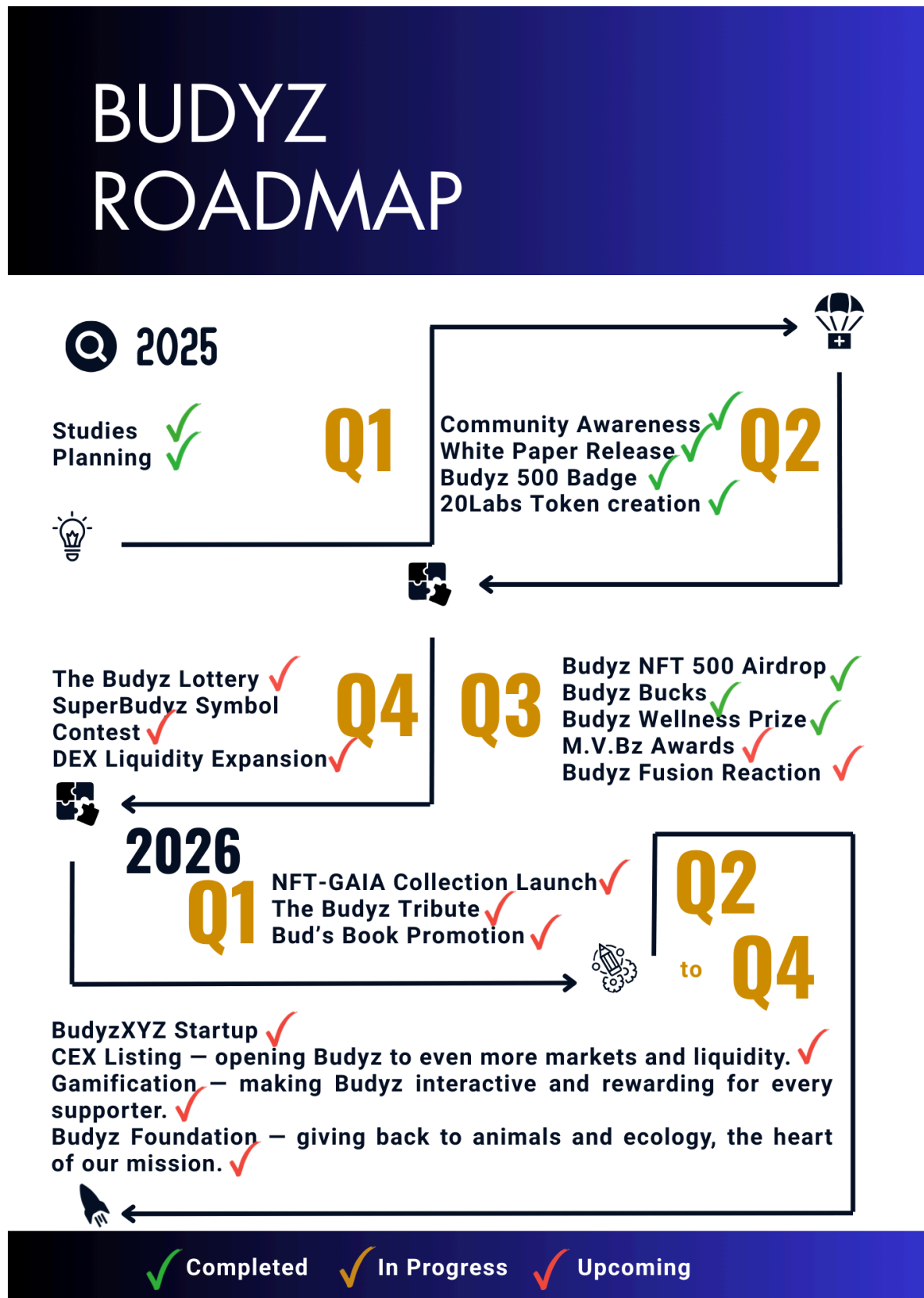

Telegram moderation prioritizes speed and protection over discussion.

Discord serves as a structured, community-building environment, suitable for:
